Students who have been dropped for non-payment may request to be reinstated in the courses from which they were dropped by submitting this form.

- Students need to first meet with the Office of Financial Aid to discuss payment and financial aid options, even if not receiving financial aid.
- Students can choose to be reinstated in any or all classes from which they were dropped for non-payment, provided the classes have not since filled to capacity.
- If this form is submitted within 5 business days of being dropped for non-payment the instructor's permission is not required.
- · After 5 business days from being dropped, students may be reinstated into courses with instructor signature.
- If reinstated, students are responsible for payment of all tuition and fees, including the \$100 reinstatement fee and \$125 late payment fee.
- The deadline to reinstate into courses after being dropped for non-payment is the same as the last day to withdraw on the academic calendar.
