# Update from the School of Management's Executive Management Committee ...

UAF's Leadership Initiative Task Force, chaired by SOM professor Susan Herman, has just received a \$78,000 grant to pilot a unique leadership program especially designed for Alaska Scholars. The purpose of the AK scholars program, according to President Mark Hamilton, is to build capacity for Alaska by keeping our brightest and our best here at home. President Hamilton has identified a needed component to the AK Scholars program, and that is specific and focused leadership training, so that these scholars not only earn a degree, but learn skills of networking, community service, civic responsibility and leadership.

The College of Rural Alaska, the ROTC program, the Northern Studies program, the Woods Center Student Leadership program and the enrollment office have joined the School of Management in creating the AK Scholars Leadership program which will enroll a pilot group of 50 scholars next autumn in a three-credit, year-long Leadership course (BA 294), exposing them to state leaders in government, business, the environment, health care, education, the non-profit world, and requiring each scholar to become involved in a year-long leadership project that would benefit the University, the local community, or the State.



# Faculty Spotlight: Dr. Doug Reynolds



Professor Doug Reynolds

Dr. Douglas B. Reynolds received his Bachelors degree in mechanical engineering from Colorado State University specializing in energy technology and worked as an engineer in the defense industry. He received his Ph.D. in 1994 from the University of New Mexico in oil and energy economics and spent two years in Kazakstan not long after the fall of the Soviet Union, where he taught and studied oil and energy economics. In 1997 Dr. Reynolds joined the faculty at the University of Alaska Fairbanks (UAF), but also spent two summers in Mexico City where he interacted with the economics faculty at UNAM, North America's largest university with over 250,000 students. He was the lead economics consultant for the Alaska State Legislature for natural gas pipeline issues in 2002 and developed economic models of various natural gas pipeline projects for Alaska.

Currently Dr. Reynolds is associate professor of oil and energy economics at UAF's School of Management and is the graduate director of the Masters of Science program in Natural Resource and Applied Economics. He has lived, given lectures, and studied oil and gas issues in Kazakstan, Russia, Mexico, and Norway, and speaks Norwegian and some Russian. Dr. Reynolds has published a number of academic peer reviewed journal articles, editorials, and general articles in the oil and energy field and has published two books on energy including "Scarcity and Growth Considering Oil and Energy," and "Alaska and North Slope Natural Gas."

Doug is married to Candice and they have two children, Miranda and Jonah.

# Faculty News ...

President Hamilton recently granted \$5,000 to **Professor Ping Lan** from the President's Special Project Fund (PSPF) for his project entitled "A Feasibility Study on an Innovative Medical Information System." The study will evaluate the possibility of creating medical diagnosis software used in an Information Technology driven clinic. The results of this study have the potential to standardize the treatment of common symptoms and change the structure of the current healthcare industry. Professor Lan's project

is among 17 winning projects, which were selected from 36 proposals forwarded to the President's office from all UA campuses.

**Professor Doug Reynolds** was awarded \$36,000 from Flint Hills Resources to conduct a research project centered on writing an energy book entitled "Energy Civilization". His book will look at how civilizations have used energy over the ages and how energy was a major factor in our economic growth from the first cave man's use of fire to modern man's use of oil.

Professor Doug Reynolds was the keynote speaker at the Alaska State Chamber of Commerce's annual "legislative tie-in" luncheon at the Hilton Anchorage in November, where he spoke about Alaska's natural gas strategic plan. In early December Bill White interviewed him about Alaska's natural gas issues and Doug was featured in the Anchorage Daily News (December 18, 2005). **Professor Doug Reynolds** spoke at the January 17th Fairbanks Chamber of Commerce general membership luncheon at the Westmark Gold Room. He explained why some natural gas pipeline routes are better than others and examined the relationship between oil and natural gas production and increasing industry rents.

**Professor Ping Lan** serves as the founding Editor and **Professor Laura Milner** serves as an editorial board member of a brand new peer reviewed academic journal. Published by Inderscience Enterprises Ltd with four issues per year, *International Journal of Technology Marketing* (IJTMkt) fosters discussion on the advancement of marketing practice and theory, with emphasis on technology and technology intensive products and services. The interaction of technology and marketing is an important but poorly covered area. To fill the gap, IJTMkt focuses on (1) Frameworks for better understanding of technology marketing; (2) Strategies, practices and toolkits for conducting technology marketing; (3) Issues related to managing technology marketing; (4) Cases of technology marketing; and (5) Other related areas.

UAF President Hamilton recently selected **Professor Doug Reynolds** as the recipient of the Harold T. Caven Professorship. This \$20,000 award will allow Doug to perform the activities and projects submitted in his proposal "Alaska's Energy Future".

#### IT'S TIME TO BEGIN THINKING ABOUT SUMMER INTERNSHIPS

What is an internship, and how is it different from a summer job? Both are great learning experiences, and excellent opportunities to learn, to network, and to earn significant summer money. An internship, however, is a specific academic program that involves the faculty instructor from SOM, you the student, and your supervisor at work. The internship instructor works on your behalf to interface with the job site when necessary, supports your learning, is a resource for questions and problem resolution, and is a guide to getting the most from the work experience in terms of learning, networking and making the experience a significant part of your future employability. Together we develop a learning contract outlining your learning goals for the internship, and a series of "deliverables" that will be the path toward your learning. In the process, you develop a portfolio piece that can be used as part of an employment packet, and at the completion of the summer, you present your portfolio piece to faculty and members of SOM's business advisory board.

If you are interested in a summer internship, the academic portion of which can be done on-line, here are the steps to take:

- 1. Find a summer job with learning/earning potential
- 2. Meet with Internship Coordinator Susan Herman (ffsjh@uaf.edu) to discuss course requirements and benefits.
- 3. Enroll for the internship course.
- 4. Develop an internship contract.
- 5. Follow the contract, and present the project during the last Wednesday of September, during the Fall semester.

She was also invited to speak at the Fairbanks Alaska Mining Association's monthly meeting in August, and the Fairbanks Alaska Support Industry Alliance meeting in September. Her talks generated interest and contact with local legislators and industry personnel. Sherri is currently an Adjunct Faculty member of the School of Management teaching Econ 100.
