Catalog Description

Introductory studio course on creating illustrations based on direct observations and reference sketches made throughout the Interior community. Focus is on interpretation of diverse regional landscapes using representational imagery that depicts spaces and places unique to Alaska and creating a cohesive body of work in black and white.

Course Description

A studio class for creating illustrations based on directs observations and reference sketches made on local public lands throughout the community. Focus is on conceptual problem-solving abilities, improvement of technical skills in rendering, and development of a self-expression in a personal style.

Emphasis is on interpretation of diverse regional landscapes interspersed with urban elements, focusing on representational imagery that depicts spaces and places unique to the Interior of Alaska. This is a studio class with expectations on producing work in a respectful and supportive atmosphere.

Prerequisite for F195: None.

Objectives

Students learn basic materials used in drawing, how to adapt works from reference sketches to finished pieces, and further demonstrate a working understanding of a range of visual techniques with a variety of tools and media. Students also study the work of historical and contemporary creators, and be exposed to a series of guest presenters working in this field. Students utilize basic principles of drawing such as linear and atmospheric perspective to depict space and depth on the picture plane, and employ other aesthetic criteria to compose a well-designed drawing.

Students set a professional example by demonstrating a consistent level of output, skill & presentation. Students create a cohesive body of work in black and white with added emphasis placed on experimentation in a variety of techniques and media. They will additionally be required to post completed works on-line (on either personal website or blog, or through hosted social network site such as Instagram, Pintrest, Tumblr, Imgur, Picasa, Deviant Art, MySpace or Facebook).

Grading Policy

Weekly critiques will be held in addition to daily review of works in progress and students are expected to provide commentary, insight and guidance on work from others in the class. These will be group critiques with an individual participation component that counts toward final grade. Attendance is mandatory. Any type of absence for a critique is a rare exception and must be worked out well in advance with the instructor. Students not having required work by specified deadlines will suffer a deduction in points due to lateness. Reworks are strongly encouraged. Each class session pieces are late after review/critique/due date = loss of points. Emailing the instructor with works-in-progress for feedback is highly recommended.

Course will be letter graded. Studio art classes may not be audited or graded pass/fail. Evaluations will be made on demonstrated understanding of concepts, quality and quantity of work, and relative improvement.

Students are evaluated on the basis of the following:

60% Portfolio Six finished primary pieces total; with six sets of accompanying completed preparatory roughs and requisite sketchbook studies.

20% Presentation and Participation Works must be of professional caliber and contributions to classroom discussions are expected.

20% Attendance Attendance is mandatory, and will factor overall for final grade. Due to the compressed nature of summer sessions, there will be a maximum of one excused absence, after that course grades will drop by one letter grade per absence (ex: 2 absences = A to a B; 3 = C; 4 = D; 5 absences = failure). Repeated lateness and/or leaving class early will accumulate in loss of points as well.
