COURSE DESCRIPTION:

Why is contemporary Arab–Israeli hatred so bloody and intractable? This course investigates the strife in its interlocking historical, political, religious, ethnic, and archaeological dimensions, exploring how past events and traditions are conceived—and reconceived—by opposing peoples in the light and shadow of their present situations and future aspirations. Competing claims to the land and its holy places are scrutinized through the prisms of Judaism and Islam, including their respective sacred texts (the Bible and the Quran). Governance of the region is examined in terms of its ancient, medieval, and modern conquests and political structures (ranging from the Davidic kingdom, to the Muslim caliphate, to Israeli statehood and the occupied territories). Ideological movements including Zionism, Fatah, Hamas, and Hizbullah are considered via their tenets and tactics (such as settlements, bulldozing, rocket attacks, and suicide bombings). Plans and prospects—both past and pending—for an enduring peace are evaluated.

GENERAL DESCRIPTION OF GOALS:

The instructor's goals for this course are, simply, to foster the student learning outcomes and objectives—namely:

STUDENT LEARNING OUTCOMES / OBJECTIVES:

By the conclusion of this course the diligent student will possess a foundational knowledge about the historical and contemporary catalysts that fuel suspicions and hostilities between (and among) Israelis and Palestinians. The student will also come to appreciate the thorny complexities generated by the intersecting geographic, religious, and political dynamics of contending ethnic groups. Furthermore, the student will acquire useful analytical tools to assess and contextualize future geopolitical developments in the region.

INSTRUCTIONAL METHODS:

This course will be conducted in a lecture format, featuring presentations and questions by the instructor designed to engage the students in discussions about the material and topics at hand. Visual media will be incorporated (chiefly PowerPoint, photographs, maps) to provide a more vivid context for reflection and conversation.

COURSE POLICIES:

- 50% Final project (short paper [5–7pp.] required for credit; students will have a choice from among a limited number of relevant topics/motifs provided and/or approved by the instructor).
