DELETION OF PROGRAM REQUEST

(UA Regulation 10.04.02)

Master of Arts in Music

I. Cover Memorandum

B. Reasons for requesting deletion of program:

The UAF Department of Music has proposed restructuring its current graduate degree program as a Master of Music in Performance (M.M.) degree program. The M.M. degree would replace the current Master of Arts (M.A.) degree. The M.M. proposal documents have already been submitted by the Department (Format 3).

Deletion of the M.A. in Music program is contingent upon and subsequent to approval and implementation of the proposed M.M. in Performance degree program.

An M.A. degree emphasizes broad-based experience in music history, theory, analysis, and literature through concentration in academic courses. The M.M. degree in Music Performance is better suited for students applying to doctoral programs and it better reflects and utilizes the strengths of the faculty in the UAF Department of Music.

The Department's accrediting agency, the National Association of Schools of Music (NASM), noted in its most recent degree program review (AY2010-2011) that the Department's M.A. degree does not accurately reflect either what an M.A. degree should be or what its graduate music students actually do in their course of study. By implementing the M.M. program, the Department intends to achieve compliance with NASM standards and recommendations.

By replacing the M.A. degree with the M.M. degree, the Department will delete a program for which neither the required curriculum or the required number of faculty positions are currently in place to support concentrations in Music Theory, Music History, Composition, Conducting, and Music Education.

C. Relation of program to other programs in the local unit and system:

There are no effects on enrollments elsewhere in the UA system. The current Master of Arts in Music degree program at UAF is the only graduate music degree program within the UA system.

D. Summarize effects on personnel directly involved with the program:

No faculty or workload displacements will be incurred by deleting the Master of Arts degree program. The proposed Master of Music in Performance degree will require the same faculty and administrative personnel currently involved with the M.A. program.

E. Summarize effects deletion of program will have on budget of department:

There are no effects on the Department of Music's budget through deletion of the Master of Arts program, given its replacement with the proposed Master of Music program.

F. Provide information on current student enrollment in program or courses:

There are currently seven students enrolled in the graduate music program. All are in the Music Performance concentration. Three of these students will be graduating in Spring 2013 with the current M.A. degree. Another three students are full-time first-year students on track for graduation in Spring 2014. The Department plans to award these three the M.M. degree, subject to its approval and implementation as proposed for AY2013-2014. The Department will provide a teach-out period for one current part-time graduate student, who will be allowed to graduate under the M.A. requirements. With approval of the proposed M.M. degree program, the Department will no longer enroll new students under the M.A. degree program.

The attached document includes a list of Master of Arts degree music students from the implementation of the program in 1979-1980 through 1987. The document further includes discussion of retention of the M.A. program and resource requirements.

1. Identification of Program:

Enrollment in the Master of Arts in Music degree program requires application and audition by students with an earned Bachelor's degree. Completion of the Master of Arts in Music degree requires a minimum of 30 credit hours, satisfactory completion of an oral comprehensive examination, additional requirements specific to the concentration (recital, thesis, project paper), satisfactory completion of a defense of the project paper or thesis.

Current program description:

The academic content of the graduate program is determined by the student and his or her graduate advisory committee. Each graduate student's program is individually tailored and designed to meet the student's professional interests and aspirations, consistent with program requirements.

After completing about one semester of the program, students will meet with their advisory committee to define precisely the student's major area of specialization. Such specialization is not to be conceived narrowly as a thesis topic, but rather as a broad area in which the student plans to spend a significant amount of their study. Advisory meetings may be repeated until such time as the student has satisfactorily defined the area of specialization. Each student, with the approval of the advisory committee, shall develop an appropriate final project or thesis. A thesis is required for students majoring in music theory and music history. Performance majors must present a graduate recital and prepare a supporting paper on selected aspects of the recital.

While the degree is recognized as a Master of Arts in Music, the Department has identified concentrations in Composition, Conducting, Music Education, Music History, Music Performance, and Music Theory.

Current program goals:

To develop an in depth knowledge of the essential components of music with technical mastery of musicology and music theory (harmony and form)

To develop and refine performance skills on principal instrument or voice where applicable (Performance Emphases)

To develop and refine skills in music composition where applicable (composition emphasis)

To develop and refine skills needed to conduct graduate level research in music

To develop and refine skills needed to conduct graduate level research in music (MUS 601)

To develop knowledge of theory and practice in Music Education where applicable

To develop and refine performance skills in an ensemble setting

We do anticipate some gradual increases in the enrollment level as the impact of our printed brochures becomes felt. (We have distributed this printing for about a year and a half.)

It should be noted that this program does not add significant cost to the administration of the Music program. The department receives typically two graduate teaching assistantships per year. These assistants relieve what would otherwise be heavy overloads for the resident faculty in several course areas. We have not hired any faculty or staff to teach graduate courses exclusively.

We believe that the current benefits to the department and the potential for some increase in enrollment for this program justifies retention of the program.
