To Whom It May Concern:

This is in support of the Format 5 changes to the HUMS AAS degree requirements submitted by Assistant Professor Diane McEachern.

As the Statewide Coordinator of the BSW Rural Cohort, a streamlined behavioral health academic pipeline is of utmost importance. It is especially necessary for rural students in the academic pipeline, who commit sometimes 11-12 years to accomplish the goal of a bachelor's degree. The revisions that have been submitted ensure a streamlined process from the Rural Human Services certificate, to the HUMS AAS, to the BA in Social Work degree, and possibly cut down the time to graduation by 1 to 1.5 years. This reduction of time is a needed option for students in the academic pipeline, who are all full-time employees in their community and have substantial family obligations.

Some components of the new revision that are in the best interest of the students and the program are:

- Taking out the unnecessary Practice and Practicum requirement in the HUMS degree, removal of HUMS 102, 103 and 233. This requirement would be important as in the stand alone HUMS AAS, however students in the pipeline have already completed an RHS practicum and will look forward to a 400 hour practicum in the BA degree.
- HUMS students will also have all the essential credits for the chemical dependency credential under this new revision by adding the HUMS 205. The HUMS 205 course is also 1 of 2 courses that can count as a SWK elective, so students can come into the BSW cohort having the elective requirements already complete.

I strongly support the revisions submitted as it will take out redundancy in the course requirements and streamline the academic pipeline of the RHS certificate, HUMS AAS and the BA in Social work.
