A. CHANGE IN DEGREE REQUIREMENTS: (Brief statement of program/degree changes and objectives)

In response to Special Program Review, Provost Henrichs has approved the Department of Theatre & Film's Improvement Plan which involves a major curricular overhaul. We are taking our two separate BA degrees, Theatre (THR) and Film (FLM), and combining them to create one BA in Film & Performing Arts, with the new course designator: FLPA. I use this new FLPA course designator for all our classes in the below proposed requirements.

We are expanding the current Film BA degree and phasing out our Theatre BA degree. We will maintain minors in both Theatre and Film Studies. Within our Film & Performing Arts BA, all our students will take a shared core of 3 classes and then split into either a Film Track or a Theatre Track.

The objective in all this is to become more efficient (faculty workload), play to our strengths (only Film program statewide where stage and screen performance is taught), and increase enrollment in all our classes. See more detail in answers to below questions.

In the new/proposed course requirements below, for clarity sake, I listed the new expanded Film and Performing Arts BA in its entirety (even though much of the old FLM BA stays in tact as the Film Track in the FLPA BA). I have attached at the end of this document a page that shows the Film changes marked up and integrated, but felt a clean copy below would be easiest to read. Two of the three FLPA core classes are current THR or FLM classes; one (FLPA F247) is a new course. All the classes under the proposed FILM track are current FLM classes. All the course under the proposed THEATRE track are current THR classes.

Minimum Requirements for Degree: 120 credits

The Theatre and Film Department teaches courses in media and performing arts, technology, theory and criticism. The department recognizes the importance of the role of the fine and performing arts within the humanities program of a liberal arts education. Courses in film and performing arts help develop a student's original, creative, and critical thinking, while developing mastery in technical or dramatic skills.

A degree in ~~film~~ Film and Performing Arts will provide students with a critical understanding of the history, theory and technologies of cinema, ~~and~~ new media arts, and theatre arts, while giving students the opportunities, tools and resources needed for careers in media and performing arts industries, to pursue graduate study, or become media or theatre artists. Students will take a shared core of classes in performance, production design, and filmmaking and then choose either a Film Track or Theatre Track for specific areas of study.

Film Track: Through an interdisciplinary approach to Film and media studies, the Film Track program will produce media-literate professionals who can play a leading role in an increasingly information-centered world where every profession will require skilled media creators. Film students will have opportunities to produce their own creative, time-based content for a wide variety of multimedia applications. Emphasis will be placed

on the cultures, lifestyles and environments of Alaska and the North, and the unique opportunities they afford for skilled media creators and artists.

Theatre Track: Classes and productions are open to Film and Performing Arts majors, Theatre or Film minors, and students in other fields. Students will become well-rounded and prepared artists who can contribute their design, technical, and performance skills to stage and screen work. The Theatre track places an emphasis on stage and screen practicum work so our students learn by having hands-on practical experience on both stage and screen sets. These experiences provide unique opportunities for creative expression and work force development.

D. ESTIMATED IMPACT

WHAT IMPACT, IF ANY, WILL THIS HAVE ON BUDGET, FACILITIES/SPACE, FACULTY, ETC.

Both the Theatre and Film programs housed within the Department of Theatre and Film contribute substantially to the departmental mission of providing training in the discipline of the Dramatic Arts. *We propose an expansion of the Film BA to include a track in "Theatre" while we phase out the Theatre BA.* This innovative restructuring at the departmental level will yield the most fruitful results in terms of attracting new majors, retaining current majors and minors in both Theatre and Film, increasing class enrollments, producing graduates in a timely manner, and cutting costs.

Students have *flocked* to our Film BA because we offer a *dramatic film curriculum* that prepares students to work on set and develop their own creative visions while partnering with professionals in the field through workforce development. UAA has a traditional Theatre program (with no dramatic film work) and a Journalism department that focuses their film courses on news and documentary. *No other program in the state is teaching a dramatic film curriculum.* Nowhere else in the state can actors, directors, designers, and technicians train for screen and stage. We have had numerous students from Anchorage and Southeast come to UAF because of the FRAME (on-set mentoring program) and dramatic/ narrative film focus of our BA. *This degree merger will capitalize on our unique position statewide.*

Specific to the dramatic arts is the understanding of dramatic story structure, character development, production design, creative technical skill acquisition, and the relationship between these elements and the audience. Due to the UAF Theatre program, the Film program has been established and is thriving. This expansion of the Film BA to include two tracks of Film and Theatre will offer a 21st century education in conjunction with a classical

education in stage performance, design, and directing. *A merger of our two programs will strengthen both.*

It is critical to note that the Film BA is highly dependent on the Theatre program, both administratively, as well as creatively. For more than a decade, the Theatre program identified a growing section of interest in the expansion of performing arts beyond the stage and onto screen. This interest, as expressed by incoming students and as a result of the 2004 Program Review, led to a series of curricular changes. The fruit of these efforts was the Film BA program, designed to grow our departmental enrollment and graduation rates. *Since Theatre faculty established the Film major in 2012, our department has nearly doubled its majors with a total of 64 currently enrolled Film and Theatre majors.* In Spring 2012, Theatre UAF received a Legislative Citation from the State of Alaska which states: "The Twenty-seventh Alaska State Legislature is proud to honor the UAF Theatre Department for the creation of the Film major. The contributions to the state of Alaska are necessary and important." In Spring 2013 the UAF administration approved the department to change its name to the Department of Theatre and Film.

Provost Henrichs has approved this curriculum overhaul as part of our approved Improvement Plan submitted in December 2015 as part of the Special Program Review process.

The Theatre and Film programs are affected by this shift. All of our former FLM and THR courses that were cross-listed with other departments such as Journalism, Art, and English still will be as FLPA courses cross-listed with other departments. By maintaining our strong relationships with Alaska Native Studies, Anthropology, Art, English, Foreign Languages, Journalism, History and Northern Studies, we will continue to support the interdisciplinary approach to *film studies* while maintaining a curriculum for *film production and performance* within our own department.

Film & Performing Arts (FLPA) Core:

1. All FLPA majors will take the FLPA core which will be introductory courses that train students in the fundamentals of Film and Performing Arts, focusing on what the art forms share. Our students will benefit from a small selection of courses that will provide an overview of each of the major elements of producing and performing in both film and theatrical productions. Because all of our FLPA majors (currently 64) will be required to take all FLPA core classes, we anticipate strong enrollment in all three core classes: *Fundamentals of Acting, Introduction to Production Design, and Film Set*

Production I. From this core, students will be able to choose one of two major tracks to achieve their BA.

Two Tracks:

1. Film Track: This is a streamlined, tighter version of the current Film program. We are focusing on eliminating under-enrolled electives (at the request of the Provost during the Improvement Plan process), allowing the faculty to concentrate on teaching a reduced set of courses that will have higher enrollments on a more regular basis. We have reduced the number of the upper division electives options to help focus students on their specific area of specialization.

2. Theatre Track: This is a major departure from the current Theatre program. The Theatre Track will emphasize performance classes and eliminate under-enrolled upper division design courses and, as a cost saving measure, courses taught by faculty who no longer work at UAF (Marx, Cook).

Historically, 90% of our Theatre majors are actors, so we are removing the *Design/Technical* and *Directing* tracks of the discipline and modifying the *Performance* track to reduce choice and consolidate classes to further boost enrollment. For example, THR 320 *Voice & Speech for the Actor* and THR 221 *Acting II* will now become one class.

We are eliminating most of the upper divisional design and directing courses: THR 447 *Lighting II*, THR 348 *Sound Design*, THR 343 *Scenic Design*, THR 456 *Advanced Costume Design and Construction*, and THR 432 *Directing II*. By eliminating under-enrolled courses, the remaining faculty are available to teach more film courses which are enjoying growing enrollment. As we continue to attract students interested in design and directing, we will focus their course of study through the remaining design/directing courses along with Topics in Film or Stage Production (FLPA 481), Research (FLPA 498), Practicum (FLPA 401/402), and Thesis (FLPA 499). This consolidation and restructuring will allow us to retain most of our current Theatre majors while boosting overall enrollment in our BA by offering the *only program in the state* where director, actors, and designers can study to work on both stage and screen.

Increased Practicum/ On-Set Emphasis:


To help the Department cope with the reality of fewer faculty assisting with the production process, we are increasing the Theatre Practicum credits required from students, including specifying some as FLPA 402 *Technical Practicum*, believing this will help us maintain the quality of our productions. We are also adding FLPA 403 *FRAME*, which places students on commercial film sets, as a requirement within the Film Track.


In both the Theatre and Film/Video areas, our programs have excelled by providing our students many hands-on opportunities on productions, both live performances and films, leading to our students being prepared to find work in the field immediately after college. We plan to continue this practice, and will continue to excel in the areas of practical application in support of material learned in formal classroom settings.


Minors:

Many of our current Theatre majors minor in Film, and many of our Film majors minor in Theatre. We want to keep both Theatre and Film Minors so that FLPA students in the Film Track can still minor in Theatre and FLPA students in the Theatre Track can still minor in Film Studies. Maintaining both minors in Film Studies and Theatre will also allow students across campus to continue to minor in Film Studies or Theatre. Over the past decade we have graduated 61 minors.
