A. CHANGE IN DEGREE REQUIREMENTS: (Brief statement of program/degree changes and objectives)

To make Special Education State of Alaska certification available to Post-Baccalaureate candidates by providing initial teacher certification in special education.

Additional prerequisites for those candidates who do not have a teaching certificate are listed. These candidates will also have to do an additional 3 credits of clinical practice for a total of 6 credits.

Credit requirements changed from 36 to 36 + 3 credits prerequisite (EDSE 482)

B. CURRENT REQUIREMENTS AS IT APPEARS IN THE CATALOG:

Master of Education in Special Education

Prepares K-12 special education teachers who can effectively understand state and national education issues and respond appropriately to those that are specific to Alaska, and who are culturally responsive, effective practitioners. The primary purpose of this program is to prepare special educators at the graduate level with specific training in the areas of disabilities, assessment, interventions strategies, current law and the implementation of programs including development of legally defensible federal IDEA documents. Graduates will have mastery of the Council for Exceptional Children standards for special education teachers: foundations in special education, development and characteristics of learners, individual learning differences, instructional strategies, learning environments and social interactions, communication, instructional planning, assessment, and professional and ethical practice.

The program, which shares a strong common core with the special education MEd programs at UAA and UAS, provides development in collaboration/consultation models and program development in multicultural settings. Completion of this program meets requirements for Alaska licensure as a special education teacher. Program Requirements

Master of Education in Special Education

Prepares K-12 special educators at the graduate level with specific training in the areas of disabilities, assessment, interventions strategies, current law and the implementation of programs including development of legally defensible federal IDEA documents.

Graduates will have mastery of the Council for Exceptional Children standards for special education teachers: foundations in special education, development and characteristics of learners, individual learning differences, instructional strategies, learning environments and social interactions, communication, instructional planning, assessment, and professional and ethical practice. The program will provide individuals who already possess, or are eligible for, a current Alaska teaching certificate or a Bachelor's degree with the necessary prerequisites with specific training in the area of special education. The program prepares K-12 special education teachers who can effectively understand state and national education issues and respond appropriately to those that are specific to Alaska. Special education candidates will progress through a series of developmentally sequenced field experiences for all ages, types and levels of abilities and collaborative opportunities. All program completers will provide evidence of being able to meet the standards of the national Council for Exceptional Children (CEC) content standards at a beginning Special Education teacher level.

The program, which shares a strong common core <u>and has the same credit requirements</u> with the special education master of education programs at UAA and UAS, provides development in collaboration/consultation models and program development in multicultural settings. Completion of this program meets requirements for Alaska licensure as a K-12 special education teacher.

• Current or recent experience (minimum of 12 hours) in an educational setting with children experiencing disabilities with a recommendation from their supervisor.

- Passing scores on the Praxis I or another test acceptable to the Alaska Department of Education and Early Development (DEED) before or during the first semester of classes.

Praxis I: Writing 174; Reading 175; Math 173

Or an average score of 174 with no one test being less than 172

CBEST: 123, no individual score less than 37

WEST-B: Writing 240, Reading 240, Math 240

Passing scores on the following Praxis II before or during the first semester of classes.

0014 Elementary Content Knowledge: Minimum score 143 AND

0041 English Content Knowledge: Minimum score 158

and/or

0061 Math Content Knowledge: Minimum score 116

All prerequisite courses must be completed with a minimum final grade of "B" in order to progress to the 600 level graduate certification courses.

Once the prerequisite courses and testing requirements have been met, and the applicants complete the requirements of graduate school admission, applicants will be formally admitted to the special education graduate certification program and can be begin taking 600 level classes.

All students not possessing a current Alaska teacher certificate are required to take six credits of clinical practice. Clinical practice courses are taken the last one or two semesters of the program. To enter the clinical practice, students must apply for authorization from the state of Alaska. This includes fingerprinting and a background check. Fingerprint clearance may take up to six months to complete. Submit the clinical practice application two semesters prior to the desired placement. Failure to comply with the requirement, falsification of information, or evidence of a criminal conviction that is named in the law or the Professional Teaching Practices Commission (PTPC) is considered an ethics violation. This will result in denied access to field placement in Alaska school districts. Authorization is required before clinical practice can begin.

Note: <u>D</u>EED also requires that the Praxis II elementary <u>or Content Knowledge #0014</u> or the Praxis II in the content area for secondary candidates be passed before they will issue a professional teaching certificate. <u>We recommend having 0041 English Content Knowledge or 0061 Math Content Knowledge as a prerequisite completed by the first semester of enrollment. Districts would prefer candidates have both 0041 & 0061 for teaching core classes for students who qualify for special education at the secondary level.</u>

This may improve budget with more students taking the undergraduate ED, EDSE, and EDSC courses. This will also have a slight impact on space and faculty with increased enrollment. It is uncertain at this time how many students will take advantage of this program so impact is difficult to judge. Estimate of 2-3 per semester as that is how many students from Fairbanks have enrolled in UAA or UAS program during the last year to get their initial teaching certificate in special education.
