## MOTION PASSED AS AMENDED (with 7 nays)

The UAF Faculty Senate instructs the Curricular Affairs Committee to make a careful study of the UAF academic calendar with a view toward extending the length of the semester to 840 minutes of instruction per credit hour, exclusive of the final exam period. The committee should attempt to complete its deliberations in time to submit a motion to the full Senate for action in its April 1990 meeting. In any case, the motion must be acted upon by October 1990 in order to be implemented in the 1991-92 academic year.

Effective: Immediately

Rationale: While there is considerable faculty discontent with the current UAF academic calendar, the 1990-91 calendar has already been published and advertised. If changes are to be made in the academic calendar, it is only reasonable to contemplate such changes with deliberation.

RESOLUTION PASSED AS AMENDED (unanimous approval)

The UAF Faculty Senate moves to adopt the following resolution relating to the policy on sabbatical leaves for faculty and to the manner by which they are funded.

- WHEREAS, Faculty are to be responsible for the understanding of the most current information germane to their specific areas of research and teaching; and
- WHEREAS, The concept of faculty sabbatical leave is recognized by this university and others worldwide as a means by which faculty can remain current in their specific areas of responsibility; and
- WHEREAS, Faculty of the University of Alaska, because of our geographic remoteness, are at a relative disadvantage to interact with colleagues at other universities and research centers; and
- WHEREAS, Sabbatical leave is no longer funded directly by University-wide funds, but rather is now the financial responsibility of the faculty members' administrative unit; and
- WHEREAS, Statewide policy on time in residence for faculty applying for a second or subsequent sabbatical has recently been changed from five to six years; and
- WHEREAS, The president of the University supports the concept of sabbatical leaves and recognizes that policies on funding and residence time should not have been changed; now
- THEREFORE BE IT RESOLVED, That the UAF Faculty Senate recommends that University of Alaska reestablish University-wide funds for sabbaticals and that the residence requirement for second, and subsequent, sabbaticals revert back to the previous period of five years.
- BE IT FURTHER RESOLVED, That the Faculty Senate requests the Chancellor to make the reinstitution of sabbatical leave funds a top priority in the next incremental budget request.

The UAF Faculty Senate moves to support in principle the following recommendations of the Ad Hoc Committee on Governance Structure included in the committee's February 1990 report:

- 1. The Faculty Senate amend its constitution
  - a. to include a forceful, coherent statement of purpose
  - b. to focus on legitimate faculty concerns (teaching, research, creative activity, service)
  - c. to have the major voice in shaping academic policy
  - d. to address budgetary issues while items are being discussed and ranked, so that the opinions of faculty will be considered along with those of the Executive Council.
- 2. The Faculty Senate withdraw from and recommend the dissolution of the UAF Assembly.
- 3. The Faculty Senate withdraw from and recommend the dissolution of the Statewide General Assembly.
- 4. The Faculty Senate seek direct access to the President and the Board of Regents via a Presidents' Council made up of the presidents and presidents-elect of the faculty groups at UAF, UAA, and UAS.

In addition, the University of Alaska Fairbanks, not the University of Alaska, is the degree granting institution.]
