



OGCA's purpose is to minimize conflicts of interest and assure compliance with applicable regulations and requirements for restricted funds. OGCA's responsibilities include the set up of new accounts, budget revisions, the preparation of bills and collections of amounts due from funding agencies, and compliance reviews. Other services include negotiation of awards, award modifications, annual certifications to federal agencies, and audit response. OGCA also offers 1:1 post award consultations, group grants management training, and specialized agency outreach.
