Eligible while serving

Eligibility Period:

No delimiting date per NDAA 08 as long as the member remains in the SR (eligibility typically begins the day after IADT completion for NPS members)

Total Payments:

\$11,988.00 (if all 36 months of entitlement are collected)

80% for multiple mobs of 3+ years

(80%) \$1,251.20 /2-yr Rate

(60%) \$938.40 1-yr Rate

(40%) \$547.20/90-day Rate

QUALIFICATIONS

- Activation w/ RC for 90 days or more since 9/11/01*
- Title 32 on Title 10 orders
- DD form 214 (DEMOB)

Eligibility Period:

Eligible up to 10 years after ETS

Per NDAA 08 Soldier remains eligible as long as they are in the SR / May receive ten years of post separation eligibility if member completes a Service Contract

Total Payments:

40% rate = \$19,699.20, 60% rate = \$29,548.80, 80% rate = \$39,398.40

Cost to Service member

No cost, unless Soldier participates in the \$600 "Buy-Up" program (per NDAA'08)

MGIB-AD Ch 30

\$1,564/mo (Full time)

\$1,173/mo (3/4 time)

\$782/mo (1/2 time)

QUALIFICATIONS

- 24 Month AD service
- \$1,200 paid by SM
- NEVER declined

Eligibility Period:

Eligible up to 10 years after ETS

Use while in Active Duty Status and for 10 years after separation (May restart 10 yr delimiting date based on any active duty period of 90 continuous days)

Total Payments:

< 3 yrs service = \$39,996.00,
3+ yrs

Cost to Service member

\$1,200 mandatory contribution; \$600 "Plus-Up" contribution is voluntary
service = \$49,248.00

Post 9/11 Ch 33

Payout is based on percentage of entitlement.

For example:

18 qualifying months =

70% Tuition Assistance

70% BAH-based housing

(E-5 w/ dependants rate)

70% Books & Supplies stipend

*up to \$1200 available for tutoring

**transferrable to dependants*

QUALIFICATIONS

An aggregate of 90 days or more of qualifying T10 active duty (12301a, 12301d, 12301g, 12302 or 12304) commencing on or after 11 September 2001

Eligibility Period:

Eligible up to 10 years after ETS

While on active duty and for 15 years after separation from qualifying active duty service or until benefits months are exhausted

Total Payments:
